SECTION 4: First aid measures

4.1 Description of first aid measures

General notes

Do not leave affected person unattended. Remove victim out of the danger area. In case of unconsciousness place person in the recovery position. Never give anything by mouth. Take off immediately all contaminated clothing. Wash contaminated clothing before reuse. In all cases of doubt, or when symptoms persist, seek medical advice.

Following inhalation

Provide fresh air. If breathing is irregular or stopped, immediately seek medical assistance and start first aid actions. In case of respiratory tract irritation, consult a physician.

Following skin contact

Following eye contact

Irrigate copiously with clean, fresh water for at least 15 minutes, holding the eyelids apart. Remove contact lenses, if present and easy to do. Continue rinsing. If eye irritation persists: Get medical advice/attention.

Following ingestion

Rinse mouth with water (only if the person is conscious). Do NOT induce vomiting. In case of vomiting keep the head low so that stomach contents cannot enter the lungs. Immediately call a POISON CENTER/doctor.

4.2 Most important symptoms and effects, both acute and delayed

If inhaled

Irritation, cough, dizziness, headache.

If on skin

Defatting or cracking of the skin, skin dryness, irritation.

If in eyes

Redness, Irritation.

If swallowed

Aspiration into the lungs may cause chemical pneumonitis, dizziness, confusion, headache, stupor.
