SECTION 4: First aid measures

4.1 Description of first aid measures

General notes

Do not leave affected person unattended. Remove victim out of the danger area. In case of unconsciousness place person in the recovery position. Never give anything by mouth. Take off immediately all contaminated clothing. In all cases of doubt, or when symptoms persist, seek medical advice.

Following inhalation

May cause respiratory irritation, cough, dry throat, weakness.

If on skin

Causes skin irritation, redness, pain.

If in eyes

Causes serious eye irritation, redness, pain.

If swallowed

Irritation of the gastrointestinal tract, nausea, vomiting, diarrhoea.
